President Donald Trump on 7 July signed an executive order directing federal agencies to end subsidies and tax credits for renewable energy projects—principally wind and solar—that depend on supply chains controlled by foreign entities. How does the new DOI policy affect wind and solar development?

For companies involved in the development of wind and solar requiring federal permitting, consultation with federal agencies, federal funding, or federal lands, the new DOI policy significantly increases the complexity and potential duration of the federal approval process.

Is USFWS still available to process solar and wind energy projects?

In light of this uncertainty, USFWS moved to update their Information for the Planning and Consultation (IPaC) portal on July 18, 2025, to state that the resource is no longer available to process solar and wind energy projects.


What are the new wind & solar energy regulations?


